II. Provision of legal services

Majerník & Miháliková, s. r. o. law firm ("Law firm") is a limited liability company whose business is the provision of legal services.

The authorization to provide legal services was established by the inclusion of Law firm in the [list of limited liability companies maintained by the Slovak Bar Association](#), with registered office at Kolárska 4, 813 42 Bratislava, in accordance with the Act No. 586/2003 Coll. on Advocacy and on amendment of the Act No. 455/1991 Coll. on Licensed Trading (Trade License Act), as amended ("Law on Advocacy"). Advocates and associate lawyers are admitted to the Slovak Bar Association ("SAK") (more on www.sak.sk).

III. Terms of providing legal services

Law firm provides legal services on the basis of mandate agreements concluded with clients, in accordance with the relevant regulations, in particular the provisions of the Law on Advocacy and SAK regulations (more on www.sak.sk). The mandate agreements are concluded under the laws of the Slovak Republic and prospective disputes are subject to the jurisdiction of the Slovak courts.

Remuneration for legal services is always negotiated contractually before commencement of service and in compliance with the Decree of the Ministry of Justice of the Slovak Republic No. 655/2004 Coll. on the remunerations and compensations of advocates for the provision of legal services as amended.

Law firm is liable for the damage caused by the provision of legal services in accordance with the Law on Advocacy and concluded mandate agreement.

Law firm concluded professional liability insurance (insurance contract no. 411 016 169) with the insurance company Allianz - Slovenská poisťovňa, a.s., with registered office at Dostojevského rad 4, 815 74 Bratislava 1. The limit of the insurance coverage for one and all the insured events occurring during the insurance period (within one year) is 3,000,000 EUR. Insurance covers insurance events that have been caused and where the breach of

duty, respectively another circumstance, that caused the damage occurred in the territory of the Slovak Republic and the countries of the European Union.
